# Deltasect

Insecticide for use against crawling insects. Suspension concentrate insecticide. DELTASECT can be used in cracks and seams. This product works against crawling insects such as cockroaches, ants, crawling insects indoors.

DELTASECT is suitable for controlling crawling insects in areas such as houses, apartments, shopping centers, cinemas, hotels, restaurants, bars, canteens, hospitals, industrial warehouses.

## **Composition and formulation**

The product is a suspension concentrate, based on 2.394% Deltamethrine. Deltamethrine is a synthetic pyrethroid that has a neurotoxic effect (toxic to the pest's nervous system) on insects when touched or inhaled. Pyrethroids cause repetitive nerve impulses by keeping sodium ion channels open. As a result, the insects that come into contact with DELTASECT die within a few minutes to a few hours. SC - suspension concentrate.

## **Applications**

Suspension concentrate insecticide for use in cracks and seams against crawling insects such as cockroaches and ants.

Indoor use, with low pressure sprayer (hand sprayer and backpack sprayer).

50 ml of product in 5 L of water per 100 m<sup>2</sup> of surface - (1% / 1:100).

Maximum 6-8 applications per year. Application can be repeated after 2 months.

# **Toxicology and recommendations**

Apply DELTASECT using a pump or sprayer. Apply only in cracks and seams.

Dilute the product in water at a ratio of 1:100. Spray the resulting solution in a dosage of 1 liter of use solution per 20 m<sup>2</sup>. Apply the use solution by means of a low-pressure syringe (hand or backpack sprayer).

Apply with a maximum spray width of 0,1 m on the treated surfaces.

When emptying, RINSE PACKAGING THOROUSLY using an integrated flushing device under pressure or manual rinsing three times. Use sprayer cleaner. Avoid that rinse water is flushed to the sewer. The product is not intended to be used in areas where animals are housed. Therefore, exposure to housed animals is not expected.

Use only as an insecticide. Indoor use only.

Wash your hands and directly exposed skin after handling the product before eating, drinking and smoking. Do not mix with other chemicals and products.

Avoid contact with treated surfaces. Do not use in the presence of people (especially children) and pets or animals. Never store reconstituted spray solution. Prepare a new spray solution before each use.

Keep away from food, drink and animal feed. Remove food and feed before treatment. Keep away from objects that may come into contact with food, drink and animal feed. Cover water storage tanks, food preparation surfaces, food preparation equipment and cutlery with impermeable plastic prior to treatment.

Treated areas can be re-entered by humans, pets and other animals as soon as the treated surfaces are dry again.

Resistance management:

Deltamethrin is used in biocides for a limited period of time and is therefore not expected to contribute to the development of resistance in target organisms. To avoid resistance development in target organisms, it is recommended to alternate the use of products containing deltamethrin with other insecticides that do not contain pyrethroids.
